

**The Durham City Council:  
Discrimination by Fast-Tracking and the Lack of Transparency**

On April 3, 2018 a group of known anti-Israel petitioners wrote the City Council asking that their petition be put immediately on the April 5 work session agenda (1). Using his personal Gmail account, Mayor Schewel replied to City Manager Thomas Bonfield, “I...told them [even though] they are late in signing up...to call the clerk now and sign up.” (2)

In so doing so, the Mayor ignored Council policy, which clearly states speakers must sign up “ten calendar days prior to the City Council Work Session meeting at which you wish to speak.” (3)

On April 5, Beth Bruch, one of the petitioners and a donor to council person Jillian Johnson, benefiting from the rules being waived, spoke first at the work session, saying to the City Council, “We know Israel is the last country in the world to respect human rights.”

Twelve hours before the April 5 work session was even set to begin, Mayor Schewel sent City Manager Bonfield and every member of the City Council his self-authored “Statement on policing from the Durham City Council.” Schewel sent the council statement from his personal email account to the personal email accounts of Bonfield and all city council members (4), thus keeping the statement out of the eyes of the media, which regularly monitor city council emails. Mayor Schewel did not consult with the mainstream Jewish Community on his wording and later told us that no word could be changed because the Council members would not allow it.

Thus, Mayor Schewel wrote policy that discriminated against Israel and Jews without allowing even a single minute of public discussion and without including the mainstream Jewish community.

At a later date, I made a public records request for city council-related emails that reside in DeDreana Freeman’s personal email account. Juliet Black, Executive Assistant in the Office of the Mayor and Council, wrote to the City Clerk in response to my request, “please note Council Freeman wants all of the emails blackened out.” That is concerning. (5)

Charlie Reece wrote to the City Attorney, Patrick Baker, “I have received a public records request for certain email messages sent and received from my personal Gmail account. Just over 1,300 emails are responsive to the request.” (6)

It is clear that Durham City Council were fast tracking anti-Israel policy behind the veil of personal email accounts.

In this manner, the Durham City Council hastily initiated, supported and sponsored a “Statement” that adhered only to wishes of a national and local organization that despises Israel. The Durham City Council broke their own scheduling policy and used personal email accounts to cloak their actions against Israel and the Jewish community. By doing so, the council initiated a government act that has led to our sense of alienation and discrimination in this community.

Dear Durham City Council and Mayor Schewel,

We, the undersigned, write to express our sense of urgency that Durham take a moral stand against militarization and violence. We are horrified by Israel's deadly response to peaceful mass protests in Gaza last Friday, including the deployment of 100 snipers and drones dropping tear gas canisters as well as the firing of rubber-coated steel bullets and live ammunition into crowds of Palestinian civilians, killing 18 and wounding more than 700. Our coalition and the many community members who support our effort feel it is critical for Durham to approve our resolution prohibiting Durham police from participating in military exchanges with Israel.

We are also well aware of the continued effects of the militarization of police departments on Black and Brown communities, as evidenced by the March 18, 2018 shooting of Saquan Clark in his grandmother's backyard by police officers in Sacramento.

This is why many people have planned to take time out of their day to show up to the afternoon council work session [this Thursday, April 5, 2018](#) to tell you why we feel so strongly that this resolution be passed as soon as possible. Our communications with Mayor Schewel had led us to believe that the resolution would be on this Thursday's agenda and likely voted on at the [Monday night](#) meeting 10 days later. Yet we have discovered that the resolution is not on the agenda. If it is not introduced until the next council work session, it would not be voted on [until May 7th](#) at the earliest.

Students from three universities are key participants in this effort and will be leaving campus in early May. We know and appreciate the fact that all council members have signed our petition or otherwise gone on record opposing these exchanges and there does not appear to be disagreement among the council members on this issue. In addition, given recent events in Gaza, we believe it is crucial that this resolution be introduced this month. To delay would be a disservice to the people of Durham.

As a result, we ask that the resolution be put on the [April 5th](#) work session agenda.
